**7: Advisors:** At least 40 (forty) advisors will be required in the association for smooth functioning of the association (under search)

**9: Executive Committee:** The Executive Committee of the association will constitute the following signatories:

1): Patron; 2): CEO/President; 3): Vice-President; 4): Secretary/ Joint Secretary; 5): Treasurer.

**Important Note:** The executive committee will be expanded later on time to time depending upon requirements and workload of the association. More advisors based on their qualification and background will be inducted in the executive committee depending upon their necessity, and requirement for the association.

**B: Executive Committee Meeting:** The executive committee meeting will be conducted every month

**B: General Body Meeting:** The general meeting of the office bearers and the volunteers will be conducted annually.

**C: Accounting:** Two types of accounts will be opened in a national bank: Current Account:

**1: General Donation Account:** Every volunteer/ Muslim/ non-muslim will donate Re. 1/- every day (Rs. 30/- per month, no maximum limit of donation depending upon the economic and wealthy conditions of the people). Every person will deposit money directly to the bank account through mandate procedure of the bank or through QR code online.

The above donation for Muslims will be mandatory, whereas, for non-muslims will be obligatory.

**2: Saving Account/Charity account: The Zakat and Sadqah (ख़ैरात और दान) will also be accepted. The persons giving zakat and Sadqah will deposit the money directly to the bank account through mandate procedure of the bank. Or through QR code online.**

**3: Auditing:** The Expenditures and utilization of the money will be kept transparent every time to prevent the possibility and expected money laundering. The auditing of the donation/ expenditure/ utilization will be conducted, when required, so that the mis-utilization and laundering of the funds could be prevented.

**Share Holding/Trading:**

All persons Muslims or Non-muslims will be invited to invest their money to the association, and then consequently the association will invest the money to different companies and industrialists. The profit or loss will then be shared and distributed among the investors of the association depending upon their shares.

### **Other General Terms and Conditions:**

**1: The money will be spent for the purpose of Secondary objectives of the association.**

**2: The volunteers will serve the association voluntarily without taking any salary or remuneration, but if felt necessary, remuneration will be given to the volunteers in some special cases depending on the availability of funds and recommended and approved by the executive committee**

**3: The money will also be utilized for giving the necessary salaries of the staffs, and honorarium/ remuneration of the volunteers/ and or invitees depending upon the availability of funds, and on approval of the Executive Body.**

**4: The money will also be utilized for conducting meetings, seminars, lectures, refreshments, and necessary travelling and field work depending upon the availability of funds, and on approval of the Executive Committee.**

**5: The executive committee of the association will allocate funds annually for different budget heads depending upon the**

availability of funds, and requirements of each budget head necessity.

6: The Office bearers will work throughout whole life, but if any office bearer is not interested to continue, he may discontinue and may resign from the association to the director giving proper reasoning and Problems. The director will then put his resignation in the meeting of the executive committee for consideration.

7: The association has expectations from all office bearers and volunteers that they will work sincerely, whole heartedly and faithfully and serve the association for the sake of benefits and welfares of humanity; and for the cause of Almighty Allah only absolutely, but if dereliction and delinquency is noted and observed from any office bearer or volunteer, the CEO/ director may ask him to leave the association or he may submit his resignation to CEO from the association.

The CEO/ director and the executive committee will seek and appoint another suitable person to hold the office position through a proper channel laid down by the executive committee either through consultations with the members of the executive committee or through election process of the executive committee or general elections of the volunteers.

8: It is expected from all office bearers and volunteers that they will remain sincere and faithful for the association whole heartedly. But if anyone is found to be astray and slipping from faithfulness, sincerity, and is found indulged in any type of politics or is observed to be involved in any objectionable activity, that may harm the association, the executive committee of the association will take note of his objectionable activities, and will take necessary steps either to curb his such activities, or expel him from the association for the sake to protect and save the benefits and interest of the association from any possible harm by his such objectionable activities.

9: The association will work strictly in the light of objectives of the association as mentioned in the Memorandum of Association (MoA), but if any other sub-objective is to be included, or any sub-objective is to be amended or revised, it will be put into the

meeting of the executive committee or general body meeting for consideration for approval.

After the approval by the general body meeting, the minutes of the meeting will be put into the meeting of executive committee for final approval. After the approval by the EC meeting that will be included in the agenda/ objectives of the association, and consequently will be implemented in the association.

10: The association will work strictly in the light of objectives of the association as mentioned in the Memorandum of Association (MoA), and expect from all office bearers and volunteers to obey and follow the four fundamental parameters of Primary objectives of the association, and obey, and follow to practice the oath/pledge (“शपथ नामह, बेप्रेत नामह بیعت نامہ”) in the life. But there will be no any pressure or compulsion for anybody to follow/practice them. However, the preaching and exhortations of such teachings mentioned therein will remain continue throughout the functioning and activities of the association.

11: The association has expectations from all office bearers and volunteers that they will believe and keep faith in the four fundamental parameters of primary objectives of the association, and will do their best efforts to follow them in practice in Toto (in full) in the life. But, if not possible at present or in the beginning, due to unavoidable circumstances; at least, it is strongly expected that they will perform Mandatory Aamal (فرائض), as ascribed by Religion-Islam, and abstain themselves from all major sins (کبیره گناه) as mentioned in the holy book of Quran, as well as will do efforts that all muslims must at least, perform Mandatory Aamal (فرائض), as ascribed by Religion-Islam, and abstain themselves from all major sins (کبیره گناه) as mentioned in the holy book of Quran.

12: The association also expect that all office bearers and volunteers will do their best efforts to invite, preach and exhort all Muslims towards good deeds and prevent them from evils.

13: The association also expect that all office bearers and volunteers along with all other Muslims will do their best efforts to maintain peace and establish communal harmony in the

country, and in the world as a whole; and to eradicate all kinds of evils and terrorism from the society as mentioned in the Memorandum of Association (MoA).

14: The volunteers who will donate regularly (Minimum Re 1/- per day or more depending his/their economic or wealthy condition) will be considered regular/permanent volunteers; and only they will have right to cast vote in all kinds of elections of the association.

15: Only regular/ permanent volunteers will be illegible for attending and participating the general body meeting of the association.

16: The funds collected will be utilized strictly for the purpose of secondary objectives of the association. But it is not necessary to utilize or spend the collected funds annually or any time. They will be kept safe and secure, and will remain deposited in the bank accounts for any major purpose mentioned in the secondary objectives of the association like opening and establishing of any university/ college/ school/ hospital for the welfare of Muslim community especially and for other communities as a whole.

17: The funds collected under zakat/ charity head/ budget will not be spent in general matters to be used for all kinds of people. They will only be spent in those purposes, wherein they will be deemed fit, like help of poor, and needy people (illegible for zakat and charity).

18: In the same way, the funds collected under the donation head/budget will be only utilized for giving Qarze Hasanah, for honorarium for and opening and establishing of university/ college/ school/ hospital for the welfare of all kinds of people in its possible limitations.

19: The funds/ donations/ contributions/ charity/ zakat etc. donated and deposited once in any form in the bank accounts of the association by any person, volunteers or any other person will become the property of the association. There will not be any refund or withdrawal or claim of that amount in any circumstances. That amount will be spent in the **Public Works Development (PWD)** of Muslim community especially and for

other communities of the nation as well mentioned in the memorandum of association (MoA).

**20: Amendments and Revisions:** Time to time there will be amendments and revisions of all matter and policies of the association depending upon need and requirements of the association. they will be put in the EC meeting for consideration and approval, and then will be implemented in the association.

**21:** The association will work independently, and will not accept any pressure or undue bias from any side. If someone wants some revision, or amendment in the article of association, he will have to submit his suggestion in writing to CEO for consideration and approval in the EC meeting.

**22:** The decision and approval of the association in all matters will be final and any kind of interference from any side in the decision of association will not be entertained and accepted.

**23:** The Office bearer will also changed time to time depending upon necessity.

**24:** Correspondence will only be done via email, telephonic conversation will not be entertained
