

01. The name of the Trust shall be **PEACE KEEPING MOVEMENT ('PKM')**.
02. That the registered office of the Trust shall be situated at RZ-3308/37, Tukglakabad Extn., South Delhi 110019, or at such other place or places as the Board of Trustees may decide from time to time. Branch / administrative offices can be opened in any part of the country for the smooth functioning of the Trust.
03. The Board of Trustees shall hold a sum of Rupees 10,000/- (Rupees Ten Thousand Only), this day paid to them and all monies, funds, other movable or immovable properties and incomes thereof which may hereinafter be received by the Board of Trustees from time to time as Gifts, Donations, Grants, Subscriptions or otherwise for the purposes of the Trust and the Trust fund shall vest in the Trustees jointly.
04. That the objectives of the Trust shall be wholly for the public and charitable purposes and incomes shall be applied for the same and accumulated in India wholly for public & charitable purposes without prejudice to generality of provisions aforesaid and the following shall be deemed to be the principal objectives of **PEACE KEEPING MOVEMENT:**
